
Weekend Camping



The Anthony Wayne Scout Reservation will be available for individual, family, unit, and patrol overnight camping beginning June 5. Unit leaders will be required to adhere to BSA, CDC, and Indiana recommendations in regards to the Covid-19. Weekend reservations may be made online with the link below or by contacting the Council Service Center.

Groups must have at least one currently registered member of the Boy Scouts of America. Proof of membership may be required. Extended (beyond weekend) camping opportunities are available and must be coordinated by contacting Cody Zimmerman, Council Program at the Council Service Center.

RESERVATION PROCEDURES

Applications for camp facilities must be received and paid in full online or at the Council Service Center at least one week prior to the dates requested. No reservations will be accepted after this date (one week prior to use) and no walk-ins will be accepted. Paid reservations are accepted on a "first come-first served" basis.

Reservation Applications with current rental fees and Service Request Forms are available for download at the council website: www.awac.org or by contacting the council service center (260-432-9593).

Between June 5 and August 2, campsite fees are \$30 per site and \$1 per participant. Vehicles associated with camping groups will not be assessed a day-use vehicle fee.

CHECK-IN PROCEDURES

Due to day programming, vehicles will not be permitted into campsites until 6pm Friday. Units are expected to check-in at camp with the Campmaster/Camp Host at Long Lake Lodge prior to 9:30 PM and not before 9:00 AM (special arrangements can be made for early/late arrivals). **Unit rosters are due at check-in.**

CANCELLATION POLICY

Cancellations of less than 3 weeks for other than weather related issues will forfeit reservation fees. If cancelled for weather related reasons, reservation fees will be refunded on a case by case basis.

ADULT LEADER POLICY FOR WEEKEND CAMPING

Each unit must provide two-deep leadership throughout the duration of the week. A minimum of 2 adults present at camp must be over 21 years of age and be registered in the BSA. All adults that remain overnight must be current registered members of the BSA and have completed the most recent Youth Protection Training

In addition, there must be a BSA registered female adult leader 21 years of age or over in every unit with females in attendance.

CUB SCOUT/WEBELOS LEADER POLICY

When participating in a pack overnight, each Cub Scout must be accompanied by an adult (one-on-one leadership). The adult must be 21 years of age or older and be registered in the BSA. All registered leaders must be youth protection trained and one adult must be BALOO trained.

VEHICLE/PARKING POLICY

Vehicles are permitted to unload in campsites and remained parked in the campsite. Vehicles are not permitted to be driving through camp for other purposes.

- When you must drive, obey the 15-MPH speed limit on the main camp road and in camp 5-MPH speed limit & all occupants are required to wear a seatbelt.
- The back of trucks, trailers, and the outside of vehicles are not to be used to transport Scouts or any other persons.
- Vehicles associated with camping groups will not be assessed a day-use vehicle fee. Vehicles will receive a vehicle pass upon arrival to be displayed at all times.

SMOKING POLICY

Adult leaders should support the attitude that they, as well as youth, are better off without tobacco in any form and may not allow the use of tobacco products at any BSA activity involving youth participants. This includes the use of electronic cigarettes, personal vaporizers, or electronic nicotine delivery systems that simulate tobacco smoking.

CAMP RULES/GUIDELINES

- 1. Build cooking and campfires only in established fire areas. When finished with any fire, be sure it is completely out.
- 2. Do not use liquid fuels for starting fires.
- 3. Campers must be in their site and quiet between the hours of 11 PM and 7 AM to allow for eight hours of sleep.
- 4. Knives and hatchets are to be used under the supervision of your leaders only. Do not carve initials or deface our trees, buildings, or equipment in any way; they belong to everybody.
- 5. Gambling, alcoholic beverages, illegal drugs, pets, fireworks, firearms, slingshots, bows and arrows, paintball guns, and other propellant devices are not permitted on council property.
- 6. Swimming & Boating on Pit Lake is not permitted without expressed permission.
- 8. Follow/Obey the Scout Oath and Law.
